ORDINANCE NO. 2026-08-04

LakePointe PID – 2026 Annual SAP Update

AN ORDINANCE OF THE CITY OF LAVON APPROVING THE 2026 ANNUAL SERVICE PLAN UPDATE AND ASSESSMENT ROLLS FOR PUBLIC IMPROVEMENTS FOR THE LAKEPOINTE PUBLIC IMPROVEMENT DISTRICT IN ACCORDANCE WITH CHAPTER 372, TEXAS LOCAL GOVERNMENT CODE, AS AMENDED; MAKING VARIOUS FINDINGS AND PROVISIONS RELATED TO THE SUBJECT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Lavon, Texas (the "City") is authorized under Chapter 372 of the Texas Local Government Code, as amended (the "Act"), to create a public improvement district within its corporate limits; and

WHEREAS, on March 19, 2019, the City Council passed and approved Resolution No. 2019-03-04, authorizing the establishment of the LakePointe Public Improvement District (the "District") in accordance with Public Improvement District (the "PID") Act, which authorization was effective upon approval in accordance with the City Council's findings as to the advisability of the public improvement projects described in the Petition and as to the advisability of creating the District; and

WHEREAS, on August 22, 2019, the City approved the 2019 Service and Assessment Plan for the District by adopting Ordinance No. 2019-08-02 which approved the levy of Assessments for Assessed Property within the District and approved the Assessment Rolls; and

WHEREAS, pursuant to Section 371.013 of the Act, the Service and Assessment Plan must cover a period of at least five years and must also define the annual indebtedness and projected costs for improvements and such Service and Assessment Plan must be reviewed and updated annually for the purpose of determining the annual budget for improvements; and

WHEREAS, the City Council has received the "City of Lavon, Texas, LakePointe Public Improvement District 2026 Annual Service Plan Update" (the "2026 Annual Service Plan Update") which includes the updated Assessment Roll, and acts as the Annual Service Plan Update to the Service and Assessment Plan for 2026, finds it to be in the public interest to adopt this Ordinance, and now desires to proceed with the adoption of this Ordinance which approves and adopts the 2026 Annual Service Plan Update and updated Assessment Rolls for the District as required by and in compliance with the Act;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAVON, TEXAS, THAT:

SECTION 1. FINDINGS. The findings and determinations set forth in the preambles hereto are hereby incorporated by reference for all purposes.

SECTION 2. TERMS. Terms not otherwise defined herein are defined in 2026 Annual Service Plan Update attached hereto as **Exhibit A.**

SECTION 3. APPROVAL OF UPDATE. The 2026 Annual Service Plan Update is hereby approved and accepted by the City Council.

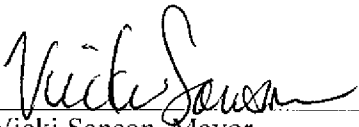
SECTION 4. SEVERABILITY. If any provision, section, subsection, sentence, clause or phrase of this Ordinance, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void or invalid, the validity of the remaining portions of this Ordinance or the application to other persons or sets of circumstances shall not be affected thereby, it being the intent of the City Council that no portion hereof, or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality, voidness or invalidity of any other portion here, and all provisions of this Ordinance are declared to be severable for that purpose.

SECTION 5. FILING IN LAND RECORDS. The City Secretary is directed to cause a copy of this Ordinance, including the 2026 Annual Service Plan Update, to be recorded in the real property records of Collin County, Texas. The City Secretary is further directed to similarly file each Annual Service Plan Update approved by the City Council, with each such filing to occur within seven days of the date each respective Annual Service Plan Update is approved.

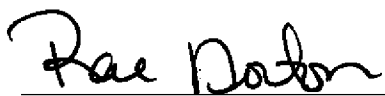
SECTION 6. EFFECTIVE DATE. This Ordinance shall take effect from and after its final date of passage, and it is accordingly so ordered.

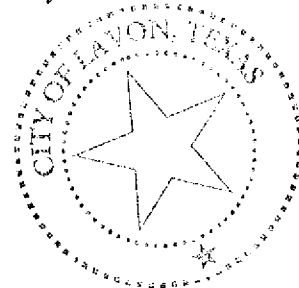
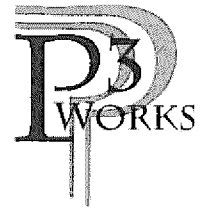

INTRODUCTION

Capitalized terms used in this 2026 Annual Service Plan Update shall have the meanings set forth in the 2022 Amended and Restated Service and Assessment Plan (the “2022 A&R SAP”).

The District was created pursuant to the PID Act by Resolution No. 2019-03-04 on March 19, 2019, by the governing body of the City (the “Governing Body”) to finance certain Authorized Improvements for the benefit of the property in the District.

On July 16, 2019, the Governing Body passed and approved Resolution No. 2019-07-03 amending Resolution No. 2019-03-04, which authorization was effective upon approval in accordance with the PID Act. The purpose of the District is to finance the Actual Costs of Authorized Improvements that confer a special benefit on approximately 173.037 acres located within the corporate limits of the City.

On August 22, 2019, the City approved the Original Service and Assessment Plan for the District by adopting Resolution No. 2019-08-02 which approved the levy of Assessments for Assessed Property within the District and approved the Assessment Rolls. The Original Service and Assessment Plan identified the Authorized Improvements to be provided by the District, the costs of the Authorized Improvements, the indebtedness to be incurred for the Authorized Improvements, and the manner of assessing the property in the District for the costs of the Authorized Improvements.

On June 16, 2020, the Governing Body approved the 2020 Annual Service Plan Update for the District by Resolution No. 2020-06-04, which updated the Assessment Roll within the District for 2020.

On August 3, 2021, the Governing Body approved the 2021 Annual Service Plan Update for the District by Resolution No. 2021-08-03, which updated the Assessment Roll within the District for 2021.

On November 16, 2021, the Governing Body approved the 2021 Amended and Restated Service and Assessment Plan by adopting Ordinance No. 2021-11-01, which served to amend and restate the Original Service and Assessment Plan in its entirety for the purposes of (1) levying the Improvement Area #2 Assessment, (2) subdividing the Major Improvement Area into Improvement Area #2 and Improvement Area #3, and (3) updated the Assessment Rolls for the District for 2021.

On September 6, 2022, the Governing Body adopted Ordinance No. 2022-09-01, which approved and accepted the 2022 Amended and Restated Service and Assessment Plan, which levied the Improvement Area #3 Assessment, and updated the Assessment Rolls for the District for 2022.

On November 15, 2022, the Governing Body adopted Ordinance No. 2022-11-01, which approved and accepted the 2022 A&R SAP, which approved the issuance of Improvement Area #2-3 bonds and updated the Assessment Rolls for the District within the District for 2022.

On August 6, 2023, the Governing Body approved the 2023 Annual Service Plan Update for the District by adopting Ordinance No. 2023-08-04, which updated the Assessment Rolls within the District for 2023.

On August 20, 2024, the Governing Body approved the 2024 Annual Service Plan Update for the District by adopting Ordinance No. 2024-08-04, which updated the Assessment Rolls within the District for 2024.

On August 5, 2025, the Governing Body approved the 2025 Annual Service Plan Update for the District by adopting Ordinance No. 2025-08-02, which updated the Assessment Rolls within the District for 2025.

The 2022 A&R SAP identified the Authorized Improvements to be constructed for the benefit of the Assessed Property within the District, the costs of the Authorized Improvements, the indebtedness to be incurred for the Authorized Improvements, and the manner of assessing the property in the District for the costs of the Authorized Improvements. Pursuant to the PID Act, the 2022 A&R SAP must be reviewed and updated annually. This document is the Annual Service Plan Update for 2026.

The Governing Body also adopted each Assessment Roll identifying the Assessments on Parcels of Assessed Property within the District, based on the method of assessment identified in the 2022 A&R SAP. This 2026 Annual Service Plan Update also updates the Assessment Rolls for 2026.

PARCEL SUBDIVISION

Improvement Area #1

- The final plat for LakePointe Phase 1 was filed and recorded with the County as 20200730010002780 on July 30, 2020.

Improvement Area #2

- The final plat for LakePointe Phase IIB was filed and recorded with the County as 20211202010004300 on December 2, 2021.
- The final plat for LakePointe Phase IIA was filed and recorded with the County as 20211209010004390 on December 9, 2021.

Improvement Area #3

- The final plat for LakePointe Phase III was filed and recorded with the County as 2023010000187 on May 10, 2023.

LOT AND HOME SALES

Current ownership within the District is based on information provided by the Owner and available information and is subject to change as development occurs and property is conveyed. Updated ownership and development information for Assessments securing PID Bonds may be available through continuing disclosure filings accessible via the Municipal Securities Rulemaking Board's Electronic Municipal Market Access ("EMMA") by searching for the District. For Assessments securing reimbursement obligations to the Owner, the summary of current ownership within the property securing such Assessment is based on information provided by the Owner and other publicly available records. See **Exhibit D** for buyer disclosures.

AUTHORIZED IMPROVEMENTS

A summary of the Authorized Improvements, including the original estimated costs of the Authorized Improvements and allocation of such costs, is provided in the 2022 A&R SAP. The Authorized Improvements and estimated costs as described in the 2022 A&R SAP are for Assessment purposes and do not represent a guarantee of construction timing or Actual Costs.

Information regarding the status of Authorized Improvements, including construction progress, estimated completion timing, and budget information, including any updates to the original estimates of costs, is based on information provided by the Owner and other available project information at the time such information is compiled. Such information may be updated from time to time.

OUTSTANDING ASSESSMENT

Improvement Area #1

Improvement Area #1 has an outstanding Assessment of \$4,750,000.00.

Improvement Area #2

Improvement Area #2 has an outstanding Assessment of \$7,507,614.66, which is less than the debt service due on the outstanding Improvement Area #2-3 Bonds due to Prepayment of Assessment for which the Improvement Area #2-3 Bonds has not yet been redeemed.

Improvement Area #3

Improvement Area #3 has an outstanding Assessment of \$6,541,266.97, which is less than the debt service due on the outstanding Improvement Area #2-3 Bonds due to Prepayment of Assessment for which the Improvement Area #2-3 Bonds has not yet been redeemed.

Major Improvement Area

Major Improvement Area has an outstanding Assessment of \$2,290,676.62, which is less than the debt service due on the outstanding Major Improvement Area Bonds due to Prepayment of Assessment for which the Major Improvement Area Bonds has not yet been redeemed.

Information for Assessments securing PID Bonds may be available through continuing disclosure filings accessible via EMMA website by searching for the District. For Assessments securing reimbursement obligations to the Owner, the summary of current construction status within the property securing such Assessment is based on information provided by the Owner and other publicly available records. ASSESSMENT ROLL

The list of current Parcels or Lots within the District, the corresponding total Assessments, and current Annual Installment are shown on the corresponding Assessment Roll attached hereto as **Exhibit A-1, A-2, A-3, and A-4**. The Annual Installment due on each Parcel or Lot may be updated to reflect prepayments and/or redemptions paid prior to the Annual Installment being billed to the owner of the Parcel or Lot. The Parcels or Lots of Assessed Property shown on the corresponding Assessment Roll will receive the bills for the 2026 Annual Installments which will be delinquent if not paid by January 31, 2027. The Parcel IDs shown within an Assessment Roll are subject to change based on the final certified rolls provided by the County prior to billing.

ADDITIONAL INFORMATION

If the owner of a Parcel claims that an error has been made in any Assessment Roll required by the 2022 A&R SAP, a prior Annual Service Plan Update, or this 2026 Annual Service Plan Update, the owner's sole and exclusive remedy shall be to submit a written notice of error to the Administrator (at admin@p3-works.com) by December 1st of the year in connection with the approval of such year's Annual Service Plan Update. Otherwise, the owner shall be deemed to have unconditionally approved and accepted the Annual Service Plan Update. The Administrator shall provide a written response to the Governing Body and the owner not later than 30 days after receipt of such written notice of error by the Administrator. The Governing Body shall consider the owner's notice of error and the Administrator's response at a public meeting, and, not later than 30 days after closing such meeting, the Governing Body shall make a final determination as to whether an error has been made. If the Governing Body determines that an error has been made, the Governing Body shall take such corrective action as is authorized by the PID Act, this 2026 Annual Service Plan Update, the applicable Assessment Ordinance, the applicable Indenture, or as otherwise authorized by the discretionary power of the Governing Body. The determination by the Governing Body as to whether an error has been made, and any corrective action taken by the Governing Body shall be final and binding on the owner and the Administrator.

EXHIBIT C-1 – IMPROVEMENT AREA #1 LOT TYPE CLASSIFICATION MAP

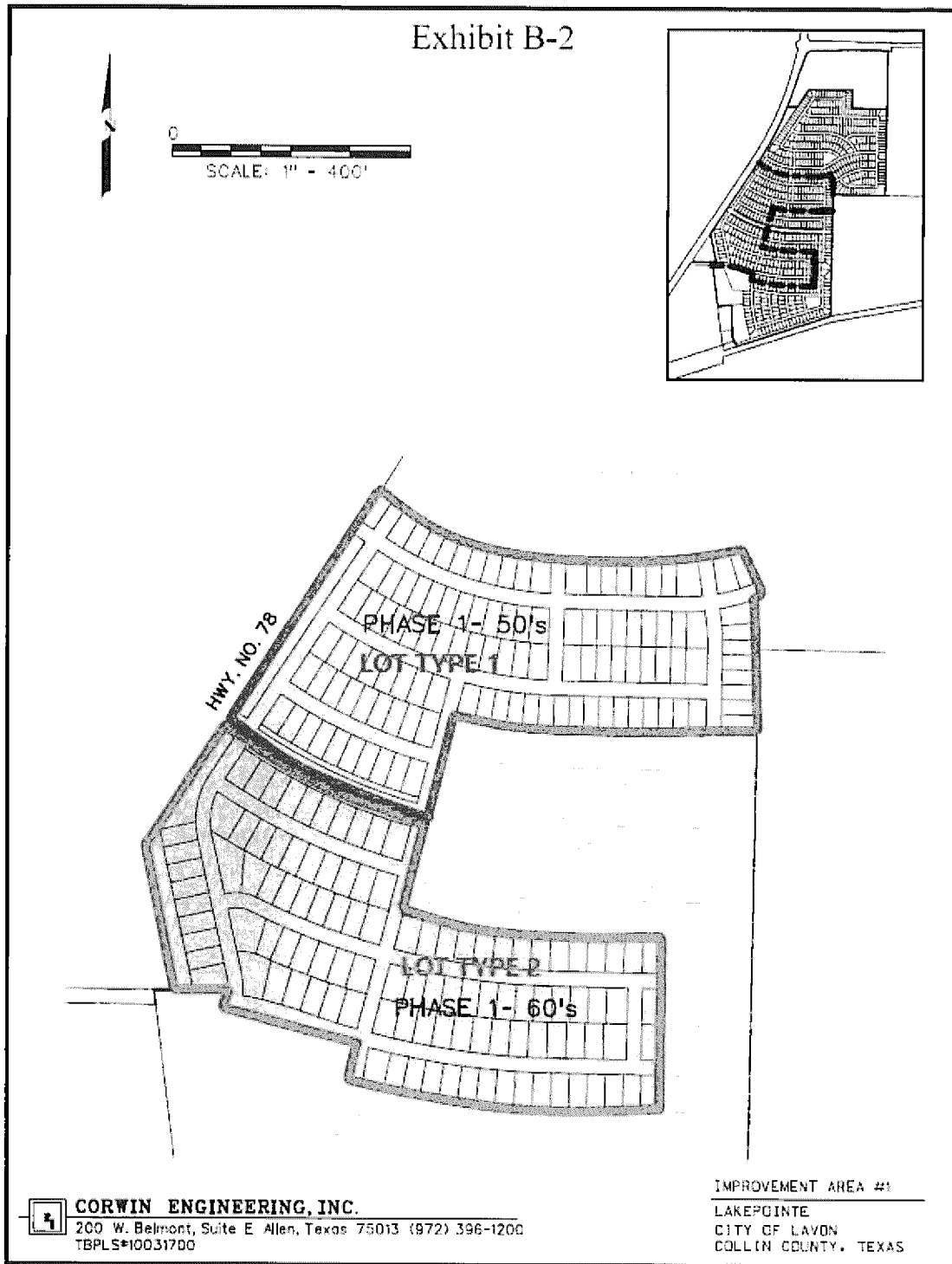


EXHIBIT C-2 – IMPROVEMENT AREA #2-3 LOT TYPE CLASSIFICATION MAP

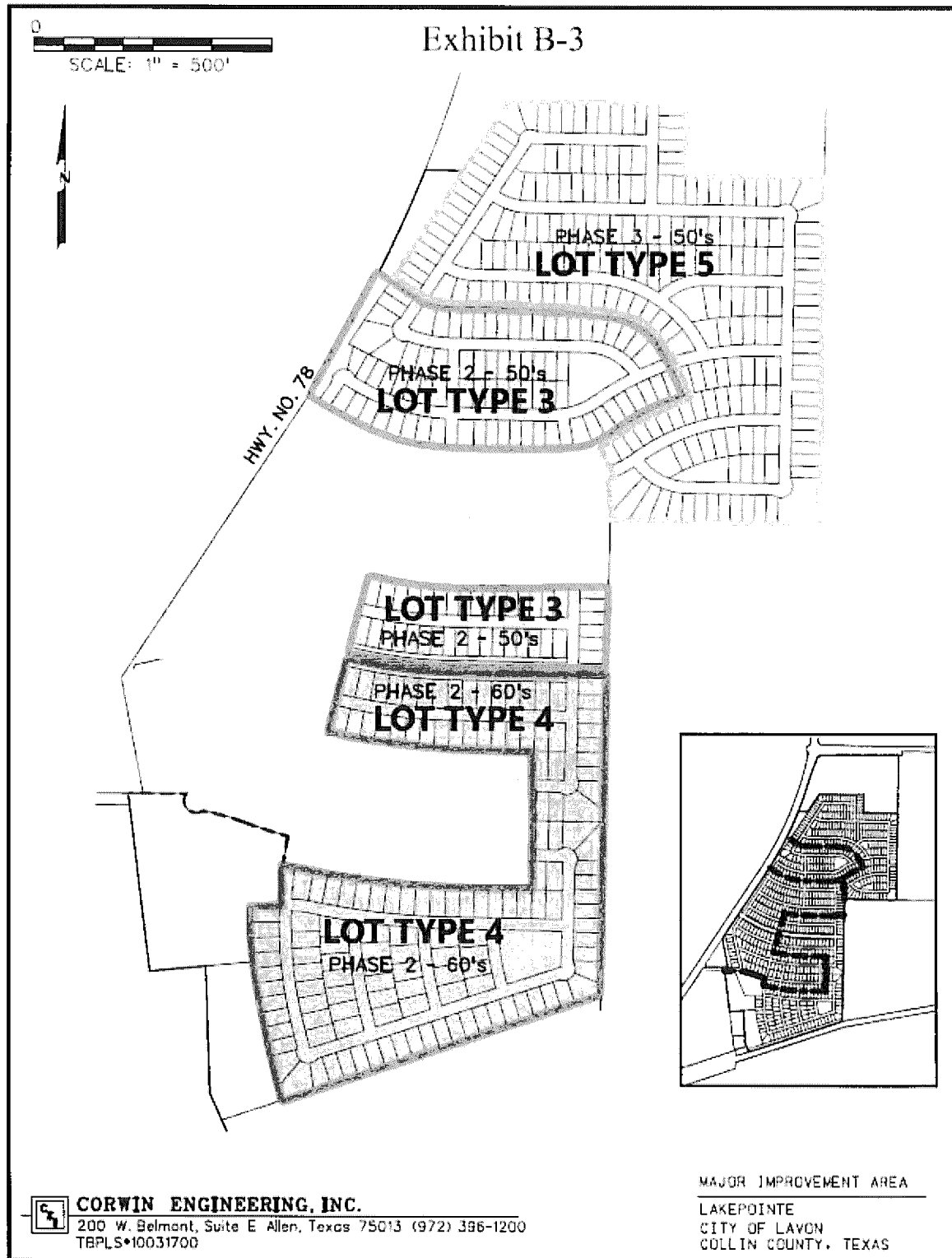
